### **§ 1 – Subject of the Contract**

The seller sells and the buyer purchases the vehicle described above. The seller declares that he/she is the legal owner of the vehicle and authorized to sell it.

### **§ 2 – Condition of the Vehicle**

The buyer confirms that he/she has inspected the vehicle and accepts its condition. All visible defects have been disclosed and are included in the price.

### **§ 3 – Warranty and Liability**

The seller excludes liability for defects of the used vehicle. The buyer acquires the vehicle in the condition at the time of contract signing.

### **§ 4 – Transfer of Ownership**

Ownership of the vehicle passes to the buyer upon full payment of the purchase price and signing of the handover protocol. All vehicle documents will be handed over with the vehicle.

**§ 5 – Duties of the Contracting Parties**

The seller undertakes to deliver the vehicle within \_\_\_\_\_ days after contract signing. The buyer undertakes to pay the price at the agreed date.
